

### About GIFT

Gulati Institute of Finance and Taxation (GIFT), formerly Centre for Taxation Studies (CTS), was conceived as a premier national Institute to promote theoretically grounded and empirically-based research within an interdisciplinary perspective to aid policymaking at the national and sub-national level. Recognized by the Indian Council of Social Science Research (ICSSR) and affiliated to Cochin University of Science and Technology, GIFT is also mandated to facilitate research leading to Ph. D. It also offers a Post Graduate Diploma in Goods and Service Taxation (PGD-GST), apart from being a highly acclaimed Institute undertaking training programs for capacity building of different stakeholders, including Government officials. The Finance Minister of the Government of Kerala is the chairperson of the Institute. Situated by the side of the National Highway near Sreekariyam on a sprawling green campus the Institute is having state of the art infrastructural facilities for research and seminars/conferences like basement parking and an airconditioned auditorium with a seating capacity of 300. While the State Government provided the land needed for the campus, the construction of the campus was made financial support offered by the Ministry of Finance, Government of India.



GIFT initiated the Research Capacity Building Program (RCBP) in 2019-20 to facilitate the creation of an interactive learning platform for research capacity building of Ph.D. scholars. Conceived as a program that goes beyond the conventional research methodology program, RCBP aims at facilitating the development of different capabilities that enable the scholars to prepare a good research proposal and its implementation. It is accomplished inter alia by interactions with eminent scholars on the making of a good Ph.D. thesis, lectures on databases and data collection along with the building up of quantitative and qualitative analytical skills to carry out research work with rigour and depth. The program also provides an opportunity for the scholars to present their research problem and get benefitted from eminent scholars and peers. Considering the imperative of reducing the dependence on proprietary software, RCBP envisages to equip the scholars to undertake data analytics using R software

RCBP is of six months programme, divided into two parts: (A) Research Methodology and (B) Data Analytics using R Software. Part A is designed to equip participants with integrated learning of methodological tools that scholars may need during the life cycle of their doctoral research and beyond. The course intends to give minimum skills in major areas so that scholars are able to independently learn advanced levels if needed for their research. Part B is to make participants proficient in statistical computing methods. After successful completion of the course, participants are expected to successfully apply their programming skills to model social science problems.

## 3 Duration

RCBP is a half-yearly program starting from June 2021 to December 2021. The course curriculum consists of two papers (for syllabus, refer to Section 8), and the medium of instruction and examination will be in English. A total of 100 teaching hours covering both Part A and Part B of the courses will be offered in online mode.

### 4 Eligibility and Admission

Who can apply: Master's degree holders in any discipline of Social Science are eligible to apply. Scholars who are currently enrolled into M.Phil/Ph.D. programs of any social science discipline are encouraged to apply. Faculty members in any social science discipline of various colleges and universities aiming to refresh their knowledge and seeking to learn new tools of data analytics are encouraged to apply. There is no age limit for joining this programme.

How to apply: The interested candidates may submit their application form along with a copy of their master's degree and no-objection certificate (NOC) from the head of the department concerned and remit the prescribed fees ONLINE only. For the online application form, follow the RCBP link on the GIFT website, www.gift.res.in.

Last date for submitting filled up application form along with Fee Receipt: June 13, 2021. For course fee details, please refer to Section 5.

Session commences: June 15, 2021.

Admission: Admission to the RCBP program will be based on duly submitting the application form along with the course fee.

Fee waiver: Full course fee waiver may be considered for the full time registered Ph.D. scholars having no financial assistance from the Universities or any other fellowship such as UGC JRF/ICSSR upon submitting a letter from the head of the department /school/institute. Those who have deregistered from the program is not eligible for fee waiver. The applicants applying for waiver need not pay any fee initially; instead, the letter must be enclosed with the application form. The number of such participants is limited to 25% of the total intake, and the waiver may be provided first come first served basis.

Payment of Fee: All fees should be paid through NEFT only. No fees will be collected in cash or by cheque or by demand draft.

Refund of Fee: Fees once paid will not be refunded. However, if the Institute rejects the application, the fees remitted will be refunded after deducting administrative charges as decided by the Institute.

Communication to Participants: All communications to the participants regarding admission, dates and examinations will be through email.

### 7 Attendance and Certificate

The students are supposed to maintain 75% attendance to get the course certificate.

This module intends to provide an in-depth exposure to various databases that include but not limited to household level (NSS data and IHDS data), firm level (ASI and PROWESS) and other macro level databases relating to labour and employment, trade and finance and other sectors of the economy.

Academic Writing, Ethics in Writing, Structure of Academic Writing, Elements of Writing, Literature Survey, Research Proposal, Publication Process.
