Gulati Institute of Finance and Taxation (GIFT) and Kerala State Higher Education Council (KSHEC) are delighted to announce the 4th edition of the Research Capacity Building Program (RCBP) for the year 2023-24. RCBP organised by GIFT in collaboration with KSHEC adopts a structured approach tailored to accommodate the diverse community of scholars nationwide. Upholds the relevance of interdisciplinary approach in social science research and is conceived as a comprehensive initiative that transcends conventional research methodology programs. It aims to nurture research, teaching, and learning capabilities while emphasizing the development of cognitive skills and ensuring high-quality learning outcomes. The program encompasses both theoretical foundations and empirical orientations (including qualitative and quantitative aspects), catering to the requirements of postgraduate students, research scholars, and faculty members in higher education. Advanced research methods and techniques will be rolled out soon at the next level.

### **About RCBP**

GIFT initiated the RCBP in 2020-21 to facilitate an interactive learning platform for the research capacity building of Scholars. Conceived as a program that goes beyond the conventional research methodology program, RCBP aims to facilitate the development of different capabilities that enable scholars to prepare a good research proposal, its implementation and the publication of output. It is accomplished inter alia by interactions with eminent scholars on making a good Ph.D. thesis, lectures on databases and data collection, and building up quantitative and qualitative analytical skills to conduct research rigorously and in-depth. The program also allows the scholars to present their research problems and benefit from eminent scholars and peers. The program participants included students, research scholars, faculties, government officials, and practitioners from different parts of the country with various disciplines. academic Hitherto, the feedback received from heterogeneous participants has been overwhelming.

## 2 Programme Structure

The RCBP 2023-24 is intricately crafted to offer thorough instruction and certification across different tiers of research methodology, specifically at foundational and applied levels. The program is envisioned to operate in a hybrid format, encompassing around 60 hours of training, with 36 hours conducted offline and the remaining 24 hours delivered online. #### Who can apply:

- Scholars currently enrolled for Ph.D. programs in any social science discipline
- · Students with a master's degree in any social science domain
- Scholars from other disciplines interested in social science research are also eligible
- · Ongoing social science master's degree students at their final year
- Faculty members in any social science discipline
- Government officials, practitioners, and others with a master's degree in any social science subjects

There is no age limit for joining the course. However, a basic understanding of statistics and/or econometrics would be desirable.
