General Instructions to students of PGD-GST

1. Training sessions start at 10. am and end at 4.30 pm with 30 minutes lunch break (6 hours). Students are requested to be present on time
2. Students have to make their own arrangements for travel, accommodation and food during the training program
3. Students are instructed to attend the Training Programmes as per the centre allotted to them based on home district mentioned in their application. However, students can attend at any other centre according to their convenience after intimating it in advance to the Course Coordinator by email.
4. During the first day of the training programme, students are instructed to bring all their relevant **original certificates (with one set of photocopy)** for verification. The originals will be returned after verification.
5. Students have to bring note books, calculators, pen, Laptop (*for practical sessions only*) for the Training Programme. The study/course materials will be despatched in batches to the students by GIFT.
